Points Discussed:

- 1. The action taken report from the previous meeting was approved.
- 2. A detailed analysis of PEO, PO, and CO attainment was presented, using survey data, placement records, and higher education statistics.
- 3. PO target levels for the 2024–2028 batch were set, and course coordinators will define CO targets based on course difficulty and student performance.
- 4. Question papers will follow Bloom's Taxonomy for cognitive diversity.
- 5. Student feedback systems and faculty evaluations will be implemented to continuously improve teaching and learning outcomes.
- 6. Feedback from the 2020–2024 batch will be collected to evaluate and revise the vision, mission, and PSOs if needed.
- 7. Industry and employer feedback will also be integrated to ensure the curriculum remains relevant to job market trends.
- 8. Continuous professional development through workshops and training in new teaching methodologies and technologies was emphasized to enhance instructional quality.
- 9. New initiatives were proposed to strengthen mentoring, counseling, and academic advising.
- 10. Soft skills training programs will be introduced to improve communication, teamwork, and leadership abilities.
- 11. Interdisciplinary research opportunities, industry-sponsored projects, and innovationcentered academic activities were discussed.
- 12. Opportunities for international exchange programs, research collaborations, and hybrid/online course offerings were explored to provide students with global exposure and flexibility.
- 13. Integration of ethics, social responsibility, sustainability, and wellness into the curriculum was proposed.
- 14. A diverse and inclusive curriculum was emphasized to cater to all student backgrounds.
- 15. Building a strong alumni network for mentorship, internships, and placements was discussed.
- 16. Employer feedback and collaboration will shape future course content and skills training.
- 17. Upgrading lab facilities, creating a digital repository for teaching-learning resources, and implementing emerging technologies were identified as essential priorities.
