CURRICULUM DEVELOPMENT CELL MINUTES (07.05.2025)

The Curriculum Development Cell meeting was held on **07.05.2025** (10.30 am) at IQAC – Board Room and discussed the following points.


The Principal, Dean (Academics), The Chairman of the Board of Studies of all the programs, and the members of the Curriculum Development Cell have attended the meeting and discussed the following points.

- The Chairperson of the Curriculum Development Cell welcomed all the members.
- The Chairperson discussed the curriculum upgradation for various programmes as follows.
 1. Members discussed in detail the need for curriculum and syllabus upgradation for the UG programmes under Regulation 2022. Suggestions were made to incorporate industry-relevant topics and emerging technologies.
 2. For PG programmes under Regulation 2024, members reviewed proposals for new courses and recommended syllabus revisions to align with current academic and industry trends.
 3. The proposed modified curriculum for the M.C.A. programme under Regulation 2024 was presented. Members expressed support, emphasizing practical exposure and employability.
 4. Regarding Employability Enhancement Courses in the M.C.A. programme, it was resolved to redistribute credits more effectively to ensure balance and avoid overload in specific semesters.
 5. A proposal to introduce 1 or 2 credit courses in the M.B.A. curriculum without increasing the total passing credits was favorably considered. These courses aim to add flexibility and specialization.
 6. It was agreed to introduce Value Added Courses (VACs) in the M.B.A. programme under Regulation 2024, limited to a maximum of 10 credits, to enhance students' practical knowledge and interdisciplinary skills.
 7. The draft Scheme and Curriculum for the forthcoming B.Tech. CSBS Programme under Regulation 2022 were presented. Constructive feedback was shared, and the proposal was endorsed in principle, subject to minor revisions.

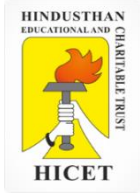

As per UGC's Curriculum and Credit Framework for UG Programmes, students must complete two NPTEL courses (totaling 6 credits) before the seventh semester, through the "Course Opt. - Phase of Study" under Regulation 2022. NPTEL courses must be scheduled within the timetable, and appropriate mentorship should be ensured to support student progress.
9. A policy was proposed whereby students who win innovation contests may be eligible to drop credit courses, subject to the following conditions:
