Minutes of Meeting

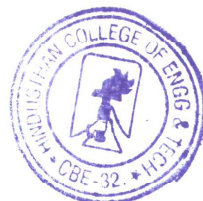
Date: 10/06/2022


